Sub : Disclosure of material impact of Covid-19 pandemic on the Company

Pursuant to Regulation 30 of LODR Regulations read with SEBI Circular No. SEBI/HO/CFD/CMDI/CINP|2020/84 dated May 20, 2020, please find herein below the disclosure of material impact of CoVID-19 pandemic on the operations and performance of the Company.

- Impact of the CoVID-19 pandemic on the business: There was a nationwide complete lockdown from 22nd March, 2020 to 20th April, 2020 and thereafter the said nationwide lockdown extended three times cumulatively from 21st April, 2020 to 31st May, 2020 with certain relaxations which impacted our production and dispatches and the impact for the same will be spread over March Quarter 2020 and June Quarter 2020.
- 2. Ability to maintain operations including the factories/units/office spaces functioning and closed down: We restarted operations w.e.f. 21st April 2020. However, due to intermittent local restrictions and order schedule deferment by the customers our plants are operating at 50-70% level as compared to the previous financial year.
- 3. Schedule, if any, for restarting the operations: Operative w.e.f. 21st April 2020.
- Steps taken to ensure smooth functioning of operations: Government SOPs are being followed diligently.
- Estimation of the future impact of CoVID-19 on its operations: We see demand revival for our products happening from September, 2020 and we further expect to reach our pre covid operating levels by December, 2020.
