This has reference to our intimation dated 30<sup>th</sup> May, 2025 with respect to re-appointment of the Secretarial Auditors of the Company in the Board Meeting dated 30<sup>th</sup> May, 2025.

Please note that in the Board Meeting dated 30<sup>th</sup> May, 2025, Mr. Navin Kothari of M/s. N K & Associates, Company Secretaries was re-appointed as the Secretarial Auditor of the Company for one term of 5(Five) consecutive years effective from 01<sup>st</sup> April, 2025 to 31<sup>st</sup> March, 2030, subject to the approval of the shareholders in the ensuing Annual General Meeting of the Company.

However, it has come to our notice that since Regulation 24A of SEBI LODRis not applicable to the Company pursuant to Regulation 15(2)(a) of the said SEBI LODR, it is not mandatory for the Company to appoint the Secretarial Auditor for a period of 5 (Five) consecutive years.

We therefore, inform that the Board of Directors of the Company at their meeting held on Wednesday,  $27^{th}$  day of August, 2025 rescinded the resolution passed for re-appointment of Secretarial Auditor for one term of 5(Five) consecutive years effective from  $01^{st}$  April, 2025 to  $31^{st}$  March, 2030 at the Board Meeting dated  $30^{th}$  May, 2025.

Further, the Board of Directors of the Company at their meeting held on Wednesday, 27th day of August, 2025 considered and approved the Re-Appointment of Mr. Navin Kothari of M/s. N K & Associates, Company Secretaries as the Secretarial Auditor of the Company for a period of 1 (One) Financial Year i.e. 2025 -2026 in compliance with Regulation 30 of SEBI LODR.
